The \$30,000 limit is placed on all contributions from members of a firm and include contributions by their spouses and children. Contributions are not tax deductible as charitable contributions for federal income tax purposes.

Under Texas law, any lawyer or other employee is considered a member of the firm. Every firm member contributor counts toward the \$30,000 contribution limit of the firm. A contribution by the spouse or child of an individual is considered a contribution by the individual. A \$5,000 limit is placed on an individual/family.
